Bridges Out of Poverty follow up	Caron explained that given the amount of feedback from people wanting to continue to progress ideas and strategies from the training, that the Collaborate meeting provides an opportunity to do this. The only problem is that the next meeting now, won't be until March 2014. Caron would like someone else to take on this role.  Each person was asked to provide a perspective of what they believe they 'got out' of the training and which areas they believe we could look at as a group. There is a lot of potential for organisations to put in place ideas and strategies identified for providing case work, however, this meeting would focus on identifying avenues for better collaboration amongst workers and services and what partnerships can be developed to address gaps and identify opportunities.

OTHER OBSERVATIONS WHAT NEXT?	<ul> <li>The value of talking to service groups about what we do</li> <li>P67 of the workbook – Developing a Bridges community</li> <li>The importance of planning strategically</li> <li>Engagement with services, workers and clients and how that can be facilitated</li> <li>Identifying the middle class barriers in approaching clients and their issues</li> <li>The complexity of issues surrounding a client before we even get to their issues</li> <li>Funding – looking at a collaborative approach esp for services with similar service delivery targets</li> <li>The need to see differences in services delivered and where</li> <li>How best to deliver a program and who to?</li> <li>Services need to be broken down to a really basic level</li> <li>Raised awareness of the intrinsic differences within middle class and poverty as models</li> <li>Observing the gaps</li> <li>Focus is on being a part of each community</li> <li>That we need to be aware that as workers we don't mistakenly believe that we need to 'fix' people or change their class structure but that it is about workers being aware of how their values and judgements fit within the client/worker framework</li> <li>Language – identified as a major issue to be aware of as a worker</li> <li>Literacy and how it affects many aspects of a persons ability to cope</li> <li>Eg Health literacy and clients not being aware of what questions to ask</li> <li>That as workers we can offer choices, and that clients HAVE choices</li> <li>Other observations included that within collaboration needs to be a similar sense of strategic direction, and matching the needs to that.</li> <li>As workers we need to challenge media and community perceptions on social issues</li> </ul>	Kylie agreed to
